EMPLOYEE SELF SERVICE MODULE

Employee self service module is a web based add-on module. An employee can login and view payslips for each month, Tax estimation statement, annual salary statement, leave, loan and reimbursement details. Employee can also enter and update investment intent and payroll admin can download those details for updating in PayPac.

Investment Declaration - Employee can submit investment declaration online. The same can be exported in excel to update in SalTds (software for TDS compliances).

Post Query - Employees have an option to post queries to admin and get clarification from them through "My Query Status".

Proof Submission - Employee can update investment proof with documents on line.
